Local User Groups Complete Land-Use Plan for Wapiti Corridor

Following extensive input from hundreds of users of the Wapiti Corridor – 235 square kilometres of land in the Wapiti River Valley between Pipestone Creek and the Smoky River – a Wapiti Corridor Multi-Use Plan has been completed and now awaits provincial government approval.

The plan establishes a framework for land use activities within the Corridor and is consistent with the Alberta Land-Use Framework. It was submitted to Alberta Environment and Sustainable Resource and Development and Alberta Tourism, Parks and Recreation in December by the Wapiti Corridor Planning Society (WCPS). WCPS is a volunteer organization represented by the Corridor’s stakeholders, including agricultural, recreational, residential, industrial and municipal interests.

The grassroots society initiated planning in 2009, in response to the growing number and diversity of users and interest groups within the Wapiti River valley. The plan makes recommendations to balance the needs of these user-groups, enhance public safety and protect the environment over the next 50 years.

Along with creating a “road-map” for current and future use in the Corridor, the plan makes recommendations for an implementation process that consists of cross jurisdictional coordination, adaptive management and shared resourcing. The WCPS has identified the need for increased enforcement within the Wapiti Corridor, to help manage potential problems and issues associated with the increasing number of users.

The County of Grande Prairie, City of Grande Prairie and the MD of Greenview have already given the plan their support. Once the plan is adopted by the Province, the WCPS will monitor and provide feedback to user groups and to Alberta Environment and Sustainable Resource Development and Alberta Tourism, Parks and Recreation and the local municipalities on the success of the plan’s implementation. The WCPS will also review and make updates to the plan every five years.

The Corridor is recognized as having some of the most unique topography in Alberta. It is also an important resource for the region. It serves as a water source for many, including the City of Grande Prairie; is an economic driver, with several industries located in the valley; is a major recreation area; and is home for a number of private residences.
