January 7, 2013

New staff introductions – County Council and staff welcomed Rikki Christie and Lindsay MacDougall.

Rikki Christie will be working as an Administrative Assistant for the Parks and Recreation department. Lindsay MacDougall will be working for Enforcement Services as a Peace Officer.

Dusty La Valley Sign Request –The Public Works department presented the proposed layout and costs to construct a sign in Bezanson recognizing local area resident and four time Canadian Bareback Riding Champion, Dusty La Valley.

LaGlace Fire Station Medical Co-Response Request – Council approved a motion for the County Fire Service to increase the levels of service provided at the LaGlace Station to include Medical Co-Response to their response area.

Council will send a letter to the LaGlace Station to congratulate and thank those dedicated to achieving their MCR designation and helping their community add this critical service.

Public Hearings – Council gave bylaw 2972 third reading. The bylaw establishes the utility rates to be charged by Aquatera for 2012.

Council gave bylaw 2680-12-058 third reading to redesignate approximately 4.05 hectares of land located within the Hamlet of Clairmont, adjacent to Rge Rd. 63 from agricultural to country residential (CR-5) to facilitate the development of one lot.

Council gave bylaw 2680-12-060 third reading to redesignate approximately 1.40 hectares of land located one mile east of Huallen and adjacent to Rge Rd. 91 from agricultural to country residential (CR-3) to facilitate the development of one lot.

Council gave bylaw 2959 third reading to preserve and designate Lake Saskatoon Townsite in the County of Grande Prairie as a Municipal Historic Resource.

Gravel Truck Upgrade – Council approved an additional \$100,000 of funding from the Infrastructure Reserve to upsize a gravel truck to a plow truck for the Public Works department. This brings the total funds for the unit to \$240,000.
