FCSS Contract with Village of Hythe – The County have entered into a three year contract with the Village of Hythe to provide all FCSS (Family and Community Support Services) programs and services in their community starting January 1, 2016. Previously, the County provided Home Support Services only.

Letter to support – Council will write a letter of support for the Alberta Forest Products Association (AFPA) to all provincial MLAs stating the importance of the forestry industry to the community and economy. AFPA emphasizes the importance in working closely with communities and industry to promote the importance of forestry and ensure that it remains a strong contributor to the provincial economy, local communities for many years to come.

Public Hearings – Council held a public hearing for Bylaw 2680-15-072 to redesignate 9.85 acres located within the Hamlet of Clairmont adjacent to Rge Rd. 55 from Agricultural (AG) District to Rural Medium Industrial (RM-2) District for the subdivision of one lot for industrial use. Council gave the bylaw third reading.

Council held a public hearing for Bylaw 2680-15-073 to redesignate 84.23 acres of land located approx. 6 ½ miles south east of Dimsdale, adjacent to Rge Rd. 70 and Twp Rd. 704 from Country Residential (CR-2) District to allow for the subdivision of 28 lots for residential use, one Municipal Reserve lot of 5.49 acres, and one Environmental Reserve lot of 49.11 acres. Council gave the bylaw third reading.

Council held a public hearing for Bylaw 2680-15-075 to redesignate 38.15 acres of land located 2 ½ miles west of the City of Grande Prairie, adjacent to Rge Rd. 71 from Agricultural (AG) District to Country Residential (CR-2) District and 36.89 acres from Country Residential (CR-5) District to Country Residential (CR-2) to allow for the subdivision of nine residential lots. Council gave the bylaw third reading.

Next Council meeting will take place on December 21, 2015.
