

# COUNCIL HIGHLIGHTS

**Aquatera Update** – Jeff Pieper, the Interim CEO and Chief Financial Officer of Aquatera, provided Council with an update on the organization’s Business Plan and capital projects.

**Public Hearings** – Council held a public hearing for Bylaw 3104 to redesignate a section of land in Whispering Ridge subdivision from a Public Utility Lot to a Municipal Reserve Lot. This redesignation will correct an error made during the registration process, as this land was always intended to be a Municipal Reserve Lot. Council gave the bylaw third reading.

Council held a public hearing for Bylaw 2680-19-007 to redesignate 39.37 acres of land located four miles east of the Hamlet of Teepee Creek, adjacent to Range Road 25 from Agricultural (AG) District to a Country Residential (CR-5) to allow for the subdivision of two new lots for residential use. Council gave the bylaw third reading.

**Minister Awards for Municipal Excellence** – The Honourable Shaye Anderson, Minister of Municipal Affairs, invited the County to apply to the 18th annual Minister’s Awards for Municipal Excellence, which recognizes excellence in local government. The County has until March 29 to apply; categories include innovation, partnership, safe communities and smaller municipalities.

**Sponsorship** – Council approved sponsorship of the 21<sup>st</sup> Annual Maple Sugar Festival, hosted by the French Canadian Association of Grande Prairie, for \$500.

Next Council meeting will take place on February 25, 2019.
