# 10:10 am- Sexsmith Vipers Junior B Hockey Club Request for Funding – Christine Rawlins, Manager of Parks and Recreation

Christine Rawlins, Manager of Parks and Recreation noted that the Sexsmith Vipers Junior B Hockey club is requesting release of their 2016 Capital Assistance funding for the construction of a team dressing room at the Sexsmith Arena. Kelly Wilson from the Sexsmith Vipers was in attendance to speak to this matter.

The Club was awarded a 2016 Capital Assistant Grant for \$12,500 for dressing room construction. The construction did not occur but the Vipers would like to move forward with the project in 2019. The organization was under the impression that the County would hold the money indefinitely.

The County sent out the Conditional Grant agreement in January of 2016 and the Club did not complete or return them to Administration. A reminder letter was sent out November 22, 2016 advising the group that funding would be cancelled if the Conditional Grant Agreements were not returned by December 31, 2016.

The funds were not carried forward in subsequent budget years, and the \$12,500 went to the bottom line at the end of 2016. There was additional discussion regarding:

## Letter Requesting Assistance - Dale Van Volkingburgh, Director of Public Works

Dale Van Volkingburgh, Director of Public Works, noted that a letter was received from Eric and Carmen DeSchipper, County residents, requesting assistance to place rocks, which were funded by Alberta Transportation, to repair a preexisting plug where the Red Willow river was diverted many years ago by the County, Alberta Transportation and Alberta Environment and Parks. The 1990 flood started the erosion of this plug and it is now nearing a point of failure. Mr. & Mrs. DeSchipper are requesting the County assist by providing equipment to place the rocks in the plug to prevent future erosion and flooding into Red Willow Flats and along Highway 722.

The approximate cost will be \$5400.00 and the County will require that all necessary permits be approved and in place prior to the County commencing work.

## Northwest Species at Risk (NWSAR) Committee Request for Letter of Support - Bill Rogan, CAO

Bill Rogan, CAO, noted that a letter was received for the Northwest Species at Risk Committee (NWSAR), of which the County is a member of, requesting support for a "boots-on-the-ground" research project in two (2) caribou ranges. This project involves spatial and qualitative data collection for the Chinchaga and Caribou Mountains Boreal Caribou Ranges. NWSAR is a collaborative partnership of five (5) municipalities in Northwest Alberta, with the support of nine (9) other municipalities, across Northern Alberta.

In December 2018, the NWSAR Committee submitted an Expression of Interest (EOI) to the Federal Environmental Damages Fund; outlining the purpose, methods and goals of the project. In January 2019, Environment and Climate Change Canada (ECCC) invited the NWSAR Committee to submit a detailed application for consideration.
