Notice is hereby given:

A. That an election will be held for the filling of the following offices:

B. That an election will be held for the election of a Senate nominee for the purposes of the *Alberta Senate Election Act*;

C. That a vote of the electors will be held on the following referendum questions under the *Referendum Act*:

Question 1: Equalization

Should section 36(2) of the Constitution Act, 1982 – Parliament and the government of Canada’s commitment to the principle of making equalization payments – be removed from the constitution?

Question 2: Daylight Saving Time

Do you want Alberta to adopt year-round Daylight Saving Time, which is summer hours, eliminating the need to change our clocks twice a year?

An Institutional Vote will take place at the Lakeview Seniors Centre (9432-113 Avenue, Clairmont, AB), for residents only, between the hours of 10:30 a.m. and 1:30 p.m. on Election Day, October 18, 2021.

In order to vote, you must produce identification for inspection. The identification must be one or more of the following as required by section 53 of the *Local Authorities Election Act*.

- One piece of photo identification issued by a Canadian government or agency which includes the elector’s name and current address (ie. Operator/Driver’s License; Government Photo Identification Card (for non-driver’s); or
- One piece of identification authorized by the Chief Electoral Officer under the Election Act that establishes the elector’s name and current address (ie. Government cheque or cheque stub; property tax notice; insurance policy or coverage card; utility bill, etc.) The complete authorized list can be found online at www.countygp.ab.ca/elections.
- If a voter’s identification shows a post office box number as the address instead of a residential or legal address, it can be accepted as verification of current address if it is in reasonable proximity to the voting jurisdiction.
