**AMENDING AGREEMENT TO THE  
2022 - 2026 FIRE SERVICES AGREEMENT**

BETWEEN:

**THE TOWN OF WEMBLEY**  
("Town")

- and -

**THE COUNTY OF GRANDE PRAIRIE NO. 1**  
("County")

**WHEREAS** the parties entered into a Fire Services Agreement dated January 1, 2022 for a term of five (5) years ending December 31, 2026;

**AND WHEREAS** the Town requested additional funding from the County in the amount of \$35,000 for the Town's decision to compensate volunteer firefighters;

**AND WHEREAS** the County has determined that they are not prepared to provide the requested compensation due to the Town's sole decision to pay their volunteer firefighters;

**AND WHEREAS** the County has, independent of the firefighters compensation request, evaluated the administrative commitments and associated time to provide the administrative support as stipulated in the current agreement and agreed to reduce the Administrative Fee paid to the County by the Town by 50% of the Contract Fee Paid to the Town by the County for the years 2025 and 2026;

**NOW THEREFORE** the respective municipal councils of both parties to this Agreement have approved the terms and conditions herein thereby authorizing each of the parties to enter into this Amending Agreement;

9. The Town shall pay to the County the following fees per year for the Administrative Services, payable in quarterly instalments ("Administrative Service Fees"):
