Cooperative Intermunicipal Funding Agreement Family and Community Support Services

MEMORANDUM OF A FUNDING AGREEMENT MADE THIS 6 DAY OF 0, 2019.

BETWEEN:

The County of Grande Prairie Of the first part

-and-

The Town of Sexsmith Of the second part

WHEREAS the Council of the County of Grande Prairie No. 1 has duly constituted a Family and Community Support Services (FCSS) Program in accordance with the Family and Community Support Services Act and Regulation, and

WHEREAS the Council of the Town of Sexsmith has also duly constituted a Family and Community Support Services (FCSS) Program in accordance with the Family and Community Support Services Act and Regulation, and

WHEREAS the Council of the County of Grande Prairie recognizes that County residents access FCSS services through the Town of Sexsmith FCSS and attend programs sponsored by Town of Sexsmith FCSS.

WHEREAS the Parties to the Agreement desire to employ a cooperative approach for the provision of comprehensive Family and Community Support Services.

- 1. The County of Grande Prairie Council shall contribute to the financing of the Town of Sexsmith FCSS program as follows:
 - (a) a contribution shall be determined each year by the Council of the County of Grande Prairie to equal Fifty percent (50%) of the grant received by the Town of Sexsmith from Alberta Community and Social Services or such provincial government department responsible for the administration of the FCSS program.
 - (b) TheTown of Sexsmith shall submit in writing a request for the grant, specifying the amount they will receive from the Provincial Government and the corresponding request to the County, prior to October 1
 - (c) The Town of Sexsmith agrees the grant from the County of Grande Prairie will not be used to constitue the Town or Village's matching share of the grant received from the Province of Alberta.
- 2. Payment shall be made in the first quarter of the calendar year.
- 3. Each FCSS Program receiving funds from the County of Grande Prairie shall disband any duel fee structure for county and urban residents.

- 4. The annual allocation from the County of Grande Prairie for the ensuing year shall be submitted to County Council for budget approval in December of each year and shall be transmitted to each Municipal FCSS.
- 5. The Town of Sexsmith FCSS Program shall submit a copy of their annual report to the County of Grande Prairie FCSS by April 30th of the following year.
- 6. This Agreement shall take effect from January 1, 2019.
- 7. The terms, provisions and representations contained in this agreement shall survive and shall continue in full force and effect until such time as :
 - a. a new agreement is negotiated OR
 - b. the Agreement is terminated on the 31 day of December in any year by either Party giving notice to the other Party in writing on or before September 30th of that year.
