BY-LAW NO. 2783 OF THE <u>COUNTY OF GRANDE PRAIRIE NO. 1</u>

A By-law of the County of Grande Prairie No. 1, in the Province of Alberta, to authorize the Council of the County of Grande Prairie No. 1 to amend Bylaw 2680-06-019

WHEREAS:

The Council of the County of Grande Prairie No. 1, after conducting a public hearing, passed Bylaw 2680-06-019 on March 20th, 2006 to authorize the amendment of Land Use Bylaw 2680 by redesignating certain lands for the purpose of a boundary adjustment of Lot 1, Block 1, Plan 042 6716;

AND WHEREAS:

The description of the lands identified for the said redesignation were as follows:

THAT PART OF LOT 1, BLOCK 1, PLAN 042 6716 (PT. NE 17-73-10-W6) AND PART OF NE 17-73-10-W6 BE REDESIGNATED FROM AN AGRICULTURAL GENERAL (AG) DISTRICT TO A COUNTRY RESIDENTIAL (CR-5) DISTRICT AS INDICATED IN RED ON THE ATTACHED SCHEDULE "A"

AND WHEREAS:

The description of the lands identified for redesignation should have been as follows:

THAT PART OF LOT 1, BLOCK 1, PLAN 042 6716 (PT. NE 17-73-10-W6) BE REDESIGNATED FROM A COUNTRY RESIDENTIAL (CR-5) DISTRICT TO AN AGRICULTURAL (AG) DISTRICT AND THAT PART OF NE 17-73-10-W6 BE REDESIGNATED FROM AN AGRICULTURAL (AG) DISTRICT TO A COUNTRY RESIDENTIAL (CR-5) DISTRICT AS INDICATED ON THE ATTACHED SCHEDULE "A"

NOW THEREFORE BE IT RESOLVED that Bylaw 2680-06-019 be amended by replacing the description of the lands identified for redesignation with the following:

THAT PART OF LOT 1, BLOCK 1, PLAN 042 6716 (PT. NE 17-73-10-W6) BE REDESIGNATED FROM A COUNTRY RESIDENTIAL (CR-5) DISTRICT TO AN AGRICULTURAL (AG) DISTRICT AND THAT PART OF NE 17-73-10-W6 BE REDESIGNATED FROM AN AGRICULTURAL (AG) DISTRICT TO A COUNTRY RESIDENTIAL (CR-5) DISTRICT AS INDICATED ON THE ATTACHED SCHEDULE "A" READ A FIRST, SECOND AND BY UNANIMOUS CONSENT OF ALL COUNCILLORS PRESENT, A THIRD AND FINAL TIME AND FINALLY PASSED THIS 10^{77} DAY OF APRIL, A.D. 2006.
