



## PUBLIC UTILITY LOT DESIGNATION BYLAW

A bylaw of the County of Grande Prairie No. 1, in the Province of Alberta for the purpose of the designation of municipal land as a Public Utility Lot.

WHEREAS: Council may by bylaw, pursuant to Section 665 of the Municipal Government Act, RSA 2000, c. M-26, as amended, require that a parcel of land or a part of a parcel of land that it owns, be designated as a Public Utility Lot; and

**WHEREAS:** The County of Grande Prairie No.1 owns Lot 2MR Block 1 Plan 2022467 Pt. SW-27-71-5-W6, which is the land to be designated as a Public Utility Lot; and

**WHEREAS:** The Plan of Survey attached to this Bylaw as Schedule "A" prepared by Beairsto & Associates Engineering Ltd., identifies the part of the Parcel to be designated as a Public Utility Lot;

**NOW THEREFORE**, under the authority of the Municipal Government Act, the Council of the County of Grande Prairie No. 1, in the Province of Alberta, hereby enacts as follows:

- 1. This bylaw may be cited as the Public Utility Lot Designation Bylaw.
- 2. The part of the Parcel identified on the plan of survey attached to this bylaw as Schedule "A" is to be designated as:

LOT 4PUL
BLOCK 1
PLAN 232\_\_\_\_
EXCEPTING THEREOUT ALL MINES AND MINERALS
AREA: 0.229 HECTARES (0.567 ACRES) MORE OR LESS

3. The Registrar at Alberta Land Titles is requested to, in accordance with Section 665 of the Municipal Government Act, do all things necessary to give effect to this bylaw.

This Bylaw shall come into force and effect on the third and final reading thereof.


