#### BYLAW # 3233

#### Road Closure of Portion of RGE RD 110 Undeveloped Government Road Allowance Bylaw

A bylaw of the County of Grande Prairie No. 1 in the Province of Alberta for the purpose of closing to public travel a portion of RGE RD 110 Undeveloped Government Road Allowance located along the west boundary of SW-18-69-10-W6 in accordance with Section 22 of the Municipal Government Act, Chapter M26, Revised Statues of Alberta 2000, as amended.

WHEREAS: the lands hereafter described are no longer required for public travel, and

WHEREAS: an application has been made to Council to have the road closed, and

**WHEREAS:** the Council of the County of Grande Prairie No.1 deems it expedient to provide for a bylaw for the purpose of closing to public travel certain roads, or portions thereof, situated in the said municipality, and

**WHEREAS:** notice of the intention of Council to pass a bylaw has been given in accordance with section 606 Municipal Government Act and advertised within the Town and Country Regional Newspaper on June 27, 2024, and July 4, 2024, and

**WHEREAS:** the Council was not petitioned during a Public Hearing for an opportunity to be heard by any person claiming to be prejudicially affected by the bylaw.

**NOW THEREFORE,** under the authority of the Municipal Government Act, the Council of the County of Grande Prairie No. 1, in the Province of Alberta, hereby enacts as follows:

1. That the following described road is closed to public travel for the purpose of disposing subject rights of access granted by other legislation:

MERIDIAN 6 RANGE 10 TOWNSHIP 69 ALL THAT PORTION OF THE ORIGINAL GOVERNMENT ROAD ALLOWANCE ADJOINING THE WEST BOUNDARY OF THE S.W.18-69-10-6 LYING BETWEEN TWO LINES DRAWN AT RIGHT ANGLES TO THE SAID WEST BOUNDARY THROUGH POINTS ON THE SAID WEST BOUNDARY 330.0 METRES AND 760.0 METRES RESPECTIVELY DISTANT SOUTHERLY FROM THE NORTHWEST CORNER OF THE SAID QUARTER SECTION CONTAINING 2.00 ACRES MORE OR LESS. EXCEPTING THEREOUT ALL MINES AND MINERALS

# **INTERPRETATION**

1. This Bylaw shall be cited as the "Road Closure of Portion of RGE RD 110 Undeveloped Government Road Allowance Bylaw".

6. Every provision of this bylaw is independent of all other provisions and if any provision is declared invalid by a Court, then the invalid provisions shall be severed and the remainder provisions shall remain valid and enforceable.

# **EFFECTIVE DATE**

7. This Bylaw shall come into force and effect on the third and final reading thereof.
