

**BY-LAW NO. 2756 OF THE
COUNTY OF GRANDE PRAIRIE NO. 1**

A By-law of the County of Grande Prairie No. 1, in the Province of Alberta, to authorize the Council of the County of Grande Prairie No. 1 to amend Bylaw 2745 (LaGlace Sanitary Sewage Line installation Local Improvement)

WHEREAS:

The Council of the County of Grande Prairie No. 1, passed Bylaw 2745 on April 25th, 2005 to authorize the financing, undertaking and completion of the local improvement project described in the local improvement plan authorized by Council, namely the extension of the sanitary sewage disposal line in the Hamlet of LaGlace.

AND WHEREAS:

The estimated costs of the project have now increased from what was originally estimated making it necessary to amend borrowing Bylaw 2745 revising the contribution amounts between the County and the benefitting owners as follows:

County	\$16,000.00
Benefitting owners	\$36,000.00
 Total Cost	 \$52,000.00

AND WHEREAS the portion to be contributed by the benefitting owners was to be borrowed from Alberta Capital Finance Authority or another authorized financial institution.

**NOW, THEREFORE, THE COUNCIL OF THE MUNICIPALITY DULY
ASSEMBLED, ENACTS AS FOLLOWS:**

1. That Bylaw 2745, which authorizes the borrowing of funds to complete the Hamlet of LaGlace sanitary sewage disposal line, be amended as follows:
 - a) All references to the County's contribution shall be amended from TWELVE THOUSAND TWO HUNDRED SEVENTY TWO ----- xx/ 100 (\$12,272.00) DOLLARS to SIXTEEN THOUSAND ----- xx/ 100 (\$16,000.00) DOLLARS, and;
 - b) All references to the amount to be paid by the benefitting owners shall be amended from TWENTY TWO THOUSAND SEVEN HUNDRED TWENTY EIGHT ----- xx/ 100 (\$22,728.00) DOLLARS to THIRTY SIX THOUSAND ----- xx/ 100 (\$36,000.00) DOLLARS, and;
 - c) All references to the amount to be borrowed shall be amended from TWENTY TWO THOUSAND SEVEN HUNDRED TWENTY EIGHT ---- xx/ 100 (\$22,728.00) DOLLARS to THIRTY SIX THOUSAND ---- xx/ 100 (\$36,000.00) DOLLARS.

- d) All references to the total costs of the project shall be amended from THIRTY FIVE THOUSAND ----- XX/100 (\$35,000.00) DOLLARS to FIFTY TWO THOUSAND ----- xx/100 (\$52,000.00) DOLLARS.

2. This by-law comes into force on the date it is passed.

READ A FIRST, SECOND AND BY UNANIMOUS CONSENT OF ALL COUNCILLORS PRESENT, A THIRD AND FINAL TIME AND FINALLY PASSED THIS 6th DAY OF July, A.D. 2005.
