BY-LAW NO. 2713 OF THE COUNTY OF GRANDE PRAIRIE NO. 1

A By-law of the County of Grande Prairie No. 1, in the Province of Alberta to amend Bylaw 2682, the Medical and Fire Emergency Response Bylaw.

WHEREAS Bylaw 2682 authorizing the provision of medical and fire emergency response services within the County of Grande Prairie No. 1 has been enacted upon receiving third and final reading;

AND WHEREAS, pursuant to Bylaw 2682, certain lands within the County of Grande Prairie No. 1 are prohibited from having open fires unless permitted in writing by the Chief Fire Protection Office or his designate;

AND WHEREAS certain lands contained within the restricted burning area have now been annexed into the City of Grande Prairie making it necessary to amend section 10.8 of Bylaw 2682;

NOW THEREFORE, pursuant to the Municipal Government Act, Chapter M 26, Revised Statutes of Alberta 2000, and amendments thereto, the Council of the County of Grande Prairie No. 1 duly assembled, enacts as follows:

- 1. That Bylaw 2682 be amended by deleting section 10.8.1 and inserting the following:
 - 10.8.1 All those lands contained within the perimeters described as follows:

Commencing at the Wapiti River, northerly along the west boundary of Sections Fifteen (15), Twenty-Two (22), Twenty-Seven (27) and Thirty-Four (34) all in Township Seventy (70) Range Six (6) West of the Sixth (6th) Meridian, thence easterly along the south boundary of Section Three (3) to the intersection with the south west corner of the Southwest Quarter of Section Two (2) thence northerly along the west boundary of the Southwest Quarter of Section Two, (2) Township Seventy One (71), Range Six (6) West of the Sixth (6th) Meridian thence easterly along the north boundary of the Southwest Quarter of Section Two, (2) Township Seventy One (71), Range Six (6) West of the Sixth (6th) to the northeast corner of Southwest Quarter of Section Two, (2) Township Seventy One (71), Range Six (6) West of the Sixth (6th) thence southerly to the northwest corner of the westerly subdivision parcel in the Southeast Quarter of Section Two, (2) Township Seventy One (71), Range Six (6) West of the Sixth (6th) thence easterly along the north boundary of the two subdivision parcels in the Southeast Quarter of Section Two, (2) Township Seventy One (71), Range Six (6) West of the Sixth (6th) thence southerly along the east boundary of the easterly subdivision parcel in the Southeast Quarter of Section Two, (2) Township Seventy One (71), Range Six (6) West of the Sixth (6th) to the intersection with the north boundary of Secondary Highway 668, thence easterly along the north boundary of Secondary Highway 668 to a point of intersection with the west boundary of Section One (1), Township Seventy One (71), Range Six (6), West of the Sixth (6th) Meridian, thence northerly along the west boundary

Section One (1), Township Seventy One (71), Range Six (6) West of the Sixth (6th) Meridian, thence easterly along the north boundary of Section One (1), Township Seventy One (71), Range Six (6) West of the Sixth (6th) Meridian to a point of intersection with the west boundary of Bear Creek, thence southeasterly along the west boundary of Bear Creek to the point of intersection with the Wapiti River; thence westerly along the south boundary of the Wapiti River to the point of commencement, and as more particularly shown in Red on the attached Schedule "A".

2. This bylaw shall come into affect upon the date of it finally be passed.
