## **BY-LAW NO. 2791 COUNTY OF GRANDE PRAIRIE NO. 1**

A by-law of the County of Grande Prairie No. 1, in the Province of Alberta, to amend Bylaw 2744 (LaGlace Sewage Extension)

WHEREAS the Council of the County of Grande Prairie No. 1 has passed Bylaw 2744 to impose a local improvement tax on benefiting properties relating to the extension of a sanitary sewage disposal line;

AND WHEREAS the project is now completed and the exact costs for the project are now known;

AND WHEREAS the Council of the County of Grande Prairie No. 1 deems it appropriate to amend Bylaw 2744 to adjust the amounts each benefiting property will pay;

NOW THEREFORE the Council of the County of Grande Prairie No. 1 enacts as follows:

- 1. That Bylaw 2744 be amended as follows:
  - That all references to the cost of the project be amended to FORTY SEVEN a) THOUSAND EIGHT HUNDRED FORTY ---- XX/100 (\$47,840.00) DOLLARS.
  - That all references to the contribution to the project by the County of Grande b) Prairie No. 1 at large be amended to FOURTEEN THOUSAND ONE HUNDRED FORTY FIVE ---- XX/100 (\$14,145.00) DOLLARS.
  - That all references to the amount to be collected by way of local improvement c) tax against the benefitting properties be amended to THIRTY THREE THOUSAND SIX HUNDRED NINETY FIVE ---- XX/100 (\$33,695.00).
  - That Schedules "A" and "B" be removed and the attached Schedules "A" and d) "B" be inserted.
- 2. This By-Law shall come into effect on the date of passing thereof.
