Policy Purpose

To recognize Council for their service to the ratepayers of the County of Grande Prairie No. 1.

Policy Statement

County Councillors will be eligible to receive a Council Service Pin as follows:

- Four (4) years of Councillor service;
- Eight (8) years of Councillor service;
- Twelve (12) years of Councillor service; and
- Four (4) year increments thereafter.

Definitions

“Council” means the duly elected Council members of the County of Grande Prairie No. 1.

“Councillor” means the duly elected member of Council under the Municipal Government Act to represent a Division of the County of Grande Prairie No. 1 who continues to hold office.

“County” means the municipality of the County of Grande Prairie No. 1 having jurisdiction under the Municipal Government Act and other applicable legislation.

Policy Guidelines

1. The Council Service Pin will be presented at the last Regular Council meeting prior to an election in an Election year.
2. A social event will be held every four (4) years after municipal elections to recognize those elected representatives not returning to office. Cost to be expensed to Council budget.
3. Upon leaving office each Councillor will be provided with a Council Recognition Plaque stating their years of service as a Councillor for the County.
4. Upon leaving office the Councillor’s spouse or significant other will be acknowledged in the way of a gift of a value up to \$150.00.

5. The recognition gift may be considered a taxable benefit in accordance with Canada Revenue Agency protocol.

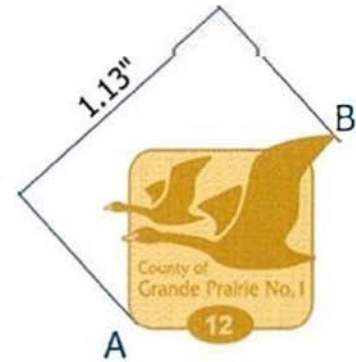
