

## **BYLAW # 3210**

### **Road Closure of Portion of Road Plan 072 2489 Bylaw**

**A bylaw of the County of Grande Prairie No. 1 in the Province of Alberta for the purpose of closing to public travel and disposing of portions of a public road in accordance with Section 22 of the Municipal Government Act, Chapter M26, Revised Statutes of Alberta 2000, as amended.**

**WHEREAS:** the lands hereafter described are no longer required for public travel, and

**WHEREAS:** an application has been made to Council to have the road closed, and

**WHEREAS:** the Council of the County of Grande Prairie No.1 deems it expedient to provide for a bylaw for the purpose of closing to public travel certain roads, or portions thereof, situated in the said municipality, and therefore disposing of the same, and

**WHEREAS:** notice of the intention of Council to pass a bylaw has been given in accordance with section 606 Municipal Government Act and advertised within the Town and Country Regional Newspaper on September 28 and October 5, and

**WHEREAS:** the Council was not petitioned for an opportunity to be heard by any person claiming to be prejudicially affected by the bylaw.

**NOW THEREFORE,** under the authority of the Municipal Government Act, the Council of the County of Grande Prairie No. 1, in the Province of Alberta, hereby enacts as follows:

1. That the following described road is closed to public travel for the purpose of disposing subject rights of access granted by other legislation:

PLAN 072 2489  
ALL THAT PORTION OF 95 AVENUE  
LYING WITHIN PLAN 232 \_\_\_\_\_  
EXCEPTING THEREOUT ALL MINES AND MINERALS

### **INTERPRETATION**

1. This Bylaw shall be cited as the "Road Closure of Portion of Road Plan 072 2489 Bylaw".
2. Headings in this Bylaw are for reference purposes only.
3. Words in the masculine gender will include the feminine gender whenever the context so requires and vice versa.
4. Words in the singular shall include the plural or vice versa whenever the context so requires.

### **DEFINITIONS**

5. In this Bylaw:
  - 5.1 "CAO" means the person appointed by Council to the position of Chief Administrative Officer or County Manager under the Municipal Government Act for the County or

designate.

- 5.2 "County" means the municipality of the County of Grande Prairie No. 1 having jurisdiction under the Municipal Government Act and other applicable legislation.

### **SEVERABILITY**

6. Every provision of this bylaw is independent of all other provisions and if any provision is declared invalid by a Court, then the invalid provisions shall be severed and the remainder provisions shall remain valid and enforceable.

### **REPEAL**

7. Bylaw 3105 and amendments thereto are hereby rescinded.

### **EFFECTIVE DATE**

8. This Bylaw shall come into force and effect on the third and final reading thereof.


