

BY-LAW NO. 3003

COUNTY OF GRANDE PRAIRIE NO. 1

A Bylaw of the County of Grande Prairie No. 1, in the Province of Alberta, for the purpose of amending the boundaries of Lot 2 ER, Plan 992 6469, located within the boundaries of the County of Grande Prairie No. 1 in accordance with Section 676 of the Municipal Government Act, Statutes of Alberta, Chapter M-26.

WHEREAS Section 676(1)(d) of the Municipal Government Act, R.S.A. 2000, c.M-26, as amended, provides that a Council may, after giving notice, change the boundaries of an environmental reserve or environmental reserve easement in order to correct an omission, error or other defect in the certificate of title, or to rectify an encroachment problem or other concern.

WHEREAS Notice of Intention of the Council to pass a bylaw has been published once a week for 2 consecutive weeks, in a newspaper circulating in the area to which the proposed bylaw relates, the last of such publications being at least five days before the day fixed for the passing of the by-law, and

WHEREAS Notice of Intention of the Council to pass a bylaw has been mailed or delivered to every residence in the area to which the proposed bylaw relates, and

WHEREAS a Public Hearing has been held to hear comments from any person wishing to be heard who may be prejudicially affected by the bylaw.

NOW THEREFORE BE IT RESOLVED that the Council of the County of Grande Prairie No. 1, duly assembled, hereby enacts the following to rectify drainage concerns:

1. Cancel that portion of LOT 2 ER, PLAN 992 6469 lying west of the production northerly of the west boundary of LOT 1A, PLAN 992 6469


EXCEPTING THEREOUT ALL MINES AND MINERALS

2. SUCH PORTION shall BE CONSOLIDATED WITH ADJACENT LOT 1B, PLAN 992 6469 into Lot 15, Block 2, Plan 142____, as surveyed by Roger C. Ross between the dates of June 7, 2012 and September 9, 2013.

AND THAT BYLAW 2994 is hereby rescinded pursuant to the provisions of Section 63 of The Municipal Government Act, Chapter M-26 of the Revised Statutes of Alberta, 200 and amendments thereto.

This Bylaw comes into effect upon the date of it finally being passed.
